- 1. Candidates admitted in the first counselling at UIET, KUK shall report to the Institute on any one of the following dates: 25 June, 26 June, 27 June, or 30 June 2026, between 9:00 AM and 5:00 PM.**
- 2. Candidates should bring all the original documents on the day of reporting with two sets of Photocopies of all documents including two coloured copies of 10+2 DMC.**
- 3. Students should take the printout of admission form (Annexure-A) and tobacco free, Medical certificate, anti-ragging forms (Annexure-B, VII, VIII & IX). He/She should bring a copy of filled forms at the time of reporting.**
- 4. Students have to pay admission fee after documents verification on the day of reporting through UPI/Netbanking/Demand draft in favour of the Director, UIET. Fee details are given in annexure-C.**
- 5. Candidates are advised to visit the UIET website regularly for updated information ([www.uietkuk.ac.in](http://www.uietkuk.ac.in)).**
- 6. As per the AICTE guidelines the last date for fee refund will be 20.07.2026, no fee refund request will be entertained after 20.07.2026.**

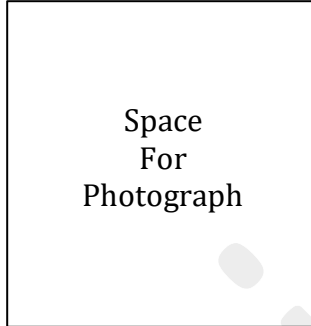
